Definitions:

Synchronous - Occurring at the same time; coinciding in time; contemporaneous; simultaneous. Synchronous instruction occurs at the same time for everyone. An example of this would be a live Zoom meeting, or class.

Asynchronous - Not occurring at the same time. An example of this would be students receiving assignments online and doing the work when they choose for that day, not at the same time as students in person in the classroom.
